

#### **END-USER LICENSE AGREEMENT** THIS IS A LEGAL DOCUMENT -- RETAIN FOR YOUR RECORDS

## **Important - Read Carefully. Notice to User:**

This End User License Agreement ("Software License Agreement") is a legal document between You (an individual or single entity) and Microix, Inc. ("Microix"). It is important that You read this document before using the Microix-provided software ("Software") and any accompanying documentation, including without limitation printed materials, 'online', or electronic documentation ("Documentation"). By clicking the 'ACCEPT' button below, by installing, or otherwise using the Software, You agree to be bound by the terms of this Software License Agreement including without limitation of liability and termination provisions below, whether or not You decide to purchase the Software. The "Product" means Microix software program and any enhancements or new releases to the Software. If You do not agree with the terms of this agreement, do not install or use the Product to Microix or an authorized Microix distributor in no event later than thirty (30) days after shipment of the Product for a refund of the product price.

## **1. SOFTWARE LICENSE**

(a) License Grant. Upon Your acceptance of this Software License Agreement Microix grants You a non-exclusive, non-transferable, revocable (as set forth in Section 8), license to use the Product solely for internal business operations and not for resale or commercial distribution. You will provide an operating environment for the Software consistent with the related Documentation. You agree not to install the system database files (or data files unique to Your organization) contained in the Software on more than one standalone PC or server, as applicable, whether at Your site or hosted by a Microix authorized commercial hosting site or facility. Where the Software is installed on a network server, You may copy local program executable files to any attached workstation as required to operate the Software from that specific workstation and which is accomplished by a separate workstation install program provided with the Software. This will allow access to the Software by each such attached workstation. The number of attached workstations and users which may access the Software concurrently is limited to the number of licenses or "seats" purchased by You for the Software as set forth in the applicable invoice.

(b) Server Use. "Use" means to install and execute the Program, provided that:

You install the Program only on a computer system that You own or only on a computer system not owned by You if You will be the only party with access to the installed Program; and
You execute the Program (i) for its intended purpose solely in connection with the management of the business that You and Your Affiliates conduct, and (ii) solely to the extent of any and all applicable limitations (whether as to specific modules or other parts of the Program, or number of production or backup server computers) set forth in this Agreement and the Supplemental License Terms; and

(3) You may make only a reasonable number of backup copies of the Program solely for the purpose of reinstalling the Program, if reinstallation becomes necessary; and(4) You may make one copy of the Program for Use in a testing environment solely for testing purposes; and,

(5) You may make and install one copy of the Program at a disaster recovery site for Your Use only for so long as a disaster or other emergency prevents You from Using the Program at Your original installation site.

- (c) Concurrent Use. You may not install the Software in any way, which would permit or authorize the Software to be used by more than the maximum number of concurrent users purchased for the Software. The permitted number of concurrent users shall be delineated at such time as You elect to purchase the Software.
- (d) Backup and Archival Copies. You may make a reasonable number of copies of the Software and Documentation provided Your backup and archival copies of the Software are not installed or used on any computer and further provided that all such copies shall bear the original and unmodified copyright, patent and other intellectual property markings that appear on or in the Software. You may not transfer the rights to a backup or archival copy.
- (e) **Key Codes.** The purchase key code will enable You to activate the Software beyond the initial evaluation period. You may not re-license, reproduce or distribute any key code except with the express written permission of Microix.
- (f) Title. Title to the Software is not transferred to You. Ownership of all copies of the Software and of copies made by You is vested in Microix, subject to the rights of use granted to You in this Software License Agreement. As between You and Microix, documents, files, sand data that are authored or created by You via Your utilization of the Software, in accordance with its Documentation and the terms of this Software License Agreement, are Your property.
- (g) **Reverse Engineering.** Except and to the limited extent as may be otherwise specifically provided by applicable law, You may not reverse engineer, decompile, disassemble or otherwise attempt to discover the source code, underlying ideas, underlying user interface techniques or algorithms of the Software by any means whatsoever, directly or indirectly, or disclose any of the foregoing, except to the extent You may be expressly permitted to decompile under applicable law, if it is essential to do so in order to achieve operability of the Software with another software program, and You have first requested Microix to provide the information necessary to achieve such operability and Microix has not made such information available. Microix has the right to impose reasonable conditions and to request a reasonable fee before providing such information. Any information supplied by Microix or obtained by You, as permitted hereunder, may only be used by You for the purpose described herein and may not be disclosed to any third party or used to create any software which is substantially similar to the expression of the Software. Requests for information should be directed to the Microix Technical Support Department.
- (h) Other Restrictions. You may not loan, rent, lease, sublicense, distribute or otherwise transfer all or any portion of the Software to third parties. You may not copy the Software except as expressly set forth above, and any copies that You are permitted to make pursuant to this Software License Agreement must contain the same copyright, patent and other intellectual property markings that appear on or in the Software. You may not modify, adapt or translate the Software. You may not, directly or indirectly, encumber or suffer to exist any lien or security interest on the Software; knowingly take any action that would cause the Software to be placed in the public domain; or use the Software in any computer environment not specified in this Software License Agreement. You will comply with applicable law and Microix's instructions regarding the use of the Software. You agree to notify Your employees and agents who may have access to the Software of the restrictions contained in this Software License Agreement and to ensure their compliance with these restrictions.

## 2. INTELLECTUAL PROPERTY RIGHTS

Acknowledgement of Microix's Rights. You acknowledge that the Software and any copies that You are authorized by Microix to make are the intellectual property of and are owned by Microix and its suppliers. The structure, organization and code of the Software are the valuable trade secrets and confidential information of Microix and its suppliers. The Software is protected by copyright, including without

limitation by United States Copyright Law, international treaty provisions and applicable laws in the country in which it is being used. You acknowledge that Microix retains the ownership of all patents, copyrights, trade secrets, trademarks and other intellectual property rights pertaining to the Software and all accompanying printed materials. You will take no actions, which adversely affect Microix's intellectual property rights in the Software. Trademarks shall be used in accordance with accepted trademark practice, including identification of trademark owners' names. Trademarks may only be used to identify printed output produced by the Software, and such use of any trademark does not give You any right of ownership in that trademark. This Software License Agreement does not grant You any intellectual property rights in the Software.

## **3. CONFIDENTIAL AND PROPRIETARY INFORMATION**

The Product is and contains valuable confidential information of Microix ("Confidential Information"). Confidential Information means non-public technical and non-technical information relating to the Product, including without limitation, trade secret and proprietary information, and the structure and organization of the Software. You will not use Confidential Information except as expressly authorized herein. You will not disclose the Confidential Information to third parties. You agree to take all reasonable steps to maintain Confidential Information in strict confidence.

## 4. MAINTENANCE AND SUPPORT

Microix offers maintenance and support of the Software or Documentation, including without limitation any bug fixes, error corrections, modifications, upgrades, updates, enhancements or new versions. You must separately purchase any maintenance and support from Microix under separate maintenance and support agreements.

## **5. FEES AND PAYMENT**

You agree to pay to Microix or the appropriate authorized Microix distributor, as applicable, all fees set forth in the applicable invoice. Such fees will be due and payable upon receipt of such invoice. All amounts due are net amounts, and You will pay taxes of any kind, including sales, use, and other similar federal, state or local taxes as may be applicable. Microix may change such fees at any time with reasonable notice to You. All amounts payable under this Agreement and the applicable invoice are denominated in United States dollars. Any terms in a purchase order, order verification, or invoice inconsistent with the terms of this Agreement will be null and void. Payments that are not received within thirty (30) calendar days of the invoice date will be considered overdue, and are subject to a late payment fee equal to the lesser of (i) 1.5% of the unpaid balance per month, or (ii) the maximum amount permitted by law.

## 6. LIMITED WARRANTY AND LIMITATION OF LIABILITY

(a) Microix warrants that, during the one (1) year period (the "Warranty Period") that commences on the date that Microix Enabled Use of the Software (whether for an initial license, an upgrade or a maintenance release under a service plan), the Program, when properly Used, shall perform substantially in accordance with the Documentation. Microix does not warrant or represent that Your use of the program will be uninterrupted or error-free. If You report to Microix in writing within the Warranty Period any non-conformity between the Documentation and the Program, and if Microix is able to replicate and verify that such non-conformity exists, Microix shall make commercially reasonable efforts to correct such non-conformity and, if successful, shall supply You with such correction at no additional cost to You. If such efforts are unsuccessful and the non-conformity is material: (1) Except for Maintenance Software, You may terminate this Agreement, discontinue Use of, and return all copies You have of the Software, and Microix will ensure that You receive a refund of the license fee You paid and credit for any license fee You owe for the Software; and (2) For Maintenance Software, You may terminate You receive a refund of, or credit You have of the Maintenance Software, and Microix will ensure that You receive a refund of, or credit

for, the service fee You incurred for the purchase of Your most recent service plan. The foregoing states Your SOLE AND EXCLUSIVE REMEDY for any breach of this warranty.

(b) With respect to any media by which You may have received Your installation copy of the Program, Microix warrants that the media is free from defects in materials and workmanship under normal use for the Warranty Period. YOUR SOLE AND EXCLUSIVE REMEDY under this warranty is limited to replacement of defective media.

(c) OTHER THAN THE EXPRESS, LIMITED WARRANTIES STATED ABOVE IN THIS SECTION, MICROIX AND ITS SUPPLIERS EXPRESSLY DISCLAIM TO THE FULLEST EXTENT PERMITTED BY LAW ALL OTHER REPRESENTATIONS, WARRANTIES, CONDITIONS AND GUARANTEES OF ANY KIND OR NATURE WHATSOEVER, WHETHER EXPRESS, IMPLIED AND STATUTORY, INCLUDING BUT NOT LIMITED TO, ANY WARRANTIES, CONDITIONS OR GUARANTEES (I) OF MERCHANTABILITY, (II) OF FITNESS FOR A PARTICULAR PURPOSE, (III) OF NON-INFRINGEMENT OF PROPRIETARY OR INTELLECTUAL PROPERTY RIGHTS OF ANY THIRD PARTY, AND (IV) ARISING FROM CUSTOM OR TRADE UMICROIXOR BY ANY COURSE OF DEALING OR COURSE OF PERFORMANCE. YOU UNDERSTAND AND AGREE THAT: (1) THE UTILITY OF A BUSINESS MANAGEMENT COMPUTER PROGRAM DECREASES AS TECHNOLOGY EVOLVES AND THE BUSINESS ENVIRONMENT CHANGES, (2) YOU ARE FREE TO DECIDE, AND ARE RESPONSIBLE FOR DECIDING, WHEN TO UPGRADE YOUR SOFTWARE, AND (3) MICROIX DISCLAIMS ANY RESPONSIBILITY TO DELIVER LATER RELEASED SOFTWARE OR OTHERWISE RENDER ANY CUSTOMER SUPPORT SERVICES EXCEPT AS MAY BE SPECIFIED IN A SEPARATE CUSTOMER MAINTENANCE AND SUPPORT AGREEMENT.

(d) Other Limitations. Microix will have no responsibility under these limited warranties for any Software or media that has been modified, lost, stolen or damaged. No employee, agent or representative of Microix, nor any reseller (including Your Distributor) or any other third party, is authorized to make any warranty with respect to the Software, except those expressly stated in this Agreement, and You may not rely on any such unauthorized warranty. You acknowledge and agree that You have chosen Your Distributor, and that such Distributor is an independent party and not an agent of Microix.

### 7. EXCLUSIONS OF AND LIMITATION OF LIABILITY

(a) You acknowledge Your understanding that software is inherently complex and may not be free from errors, and that You have been advised to verify the work produced by the Program. Neither Microix nor its suppliers shall be liable for any special, indirect, incidental, consequential or punitive damages resulting from any defect in the Software or media, even if You have been advised of the possibility of such damages. This means Microix is not responsible or liable for damages or costs incurred as a result of loss of time, loss of data, loss of anticipated profits, lost opportunity cost or loss of use of the Software, nor for damages or costs incurred in connection with obtaining substitute software, claims made against You by others or similar costs. IN NO EVENT SHALL MICROIX'S LIABILITY TO YOU ARISING OUT OF OR IN CONNECTION WITH THE SOFTWARE OR THIS AGREEMENT. WHETHER IN CONTRACT. TORT OR OTHERWISE. EXCEED THE LICENSE FEE ACTUALLY PAID BY YOU TO PURCHASE THE LICENSE FOR THE SOFTWARE. You acknowledge and agree that this Agreement allocates risk between You and Microix as authorized by applicable law, and that the pricing of Microix's products reflects this allocation of risk and the exclusions and limitations of liability contained in this Agreement. If any remedy hereunder is determined to have failed of its essential purpose, all limitations of liability and exclusion of damages set forth in this Agreement shall remain in full force and effect. (b) You acknowledge that unless You and Microix agree in writing for Microix to provide software implementation services to implement the Program at Your place of business, You are responsible for engaging a qualified party to provide implementation services for You on terms You negotiate. You also acknowledge that You are responsible for independently investigating the skills and qualifications of such party to ensure that they provide You with the level of skill and service Your business requires. You agree that Microix shall have no liability whatsoever for any failure associated with such implementation services, even if the party You engage is an authorized or certified Distributor,

consultant, or installer of Microix products.

#### 8. INDEMNIFICATION

(a) If You receive notice of any claim that Your use of any part of the Software infringes any third party's intellectual property right in a patent, copyright, or trade secret, Microix shall defend, and shall indemnify and hold You harmless by paying any resulting costs and damages finally awarded by a court with respect to any such claim provided that You:

(1) Notify Microix in writing promptly upon becoming aware of the claim,

(2) At Microix's request and expense, give Microix such information and assistance as is reasonable under the circumstances, and

(3) Give Microix the right to settle the claim in Microix's sole discretion and at Microix's expense.

(b) This indemnification does not extend to any claim based upon any alleged infringement arising from the combination of the Software with other elements not under Microix's sole control, or arising from any part of the Software that You or a third-party modify, or that incorporates specifications, designs or formulas that You provide. If You are prevented from using the Software because of an actual or claimed infringement, then at Microix's option, Microix shall promptly either obtain for You the right to continue Using the affected part of the Software, replace or modify the affected part of the Software so that it becomes non-infringing, or if none of the foregoing alternatives are possible after Microix exercises commercially reasonable efforts, You may terminate this Agreement and any service plan, and Microix shall ensure that You receive a refund of, or credit for:

(1) the service fee You incurred for the purchase of Your most recent service plan; and (2) a pro rata portion of the license fees You incurred for the purchase of Your initial license and all upgrades, which pro rata portion will be determined on the basis of the remaining period of a useful life of (5) five years, where the five year useful life begins on the date of Your purchase of Your initial license and the remaining period begins on the date You so terminate.

(c) THIS **SECTION 8** SETS OUT MICROIX'S ENTIRE FINANCIAL LIABILITY FOR ANY INTELLECTUAL PROPERTY CLAIMS OR ACTUAL INFRINGEMENTS RELATING TO THE SOFTWARE.

## 9. TERM AND TERMINATION

This Software License Agreement is effective until terminated. You may terminate this Software License Agreement at any time upon providing thirty (30) calendar days written notice to Microix. If you are unsatisfied with the Product for any reason during the first thirty (30) calendar days following the date of the shipment of the Software, you may also terminate this Software License Agreement upon providing notice to Microix, and if Microix receives such notice within such thirty (30) days period, Microix will refund you the full amount of the license fees received by Microix from you under this Software License Agreement, less any shippingcosts. Service fees (Maintenance and Support) will be prorated based on the period used. Without prejudice to any other rights, Microix, at its option, may immediately terminate this Software License Agreement if you breach or fail to comply with any provision of this Software License Agreement, including without limitation the failure to timely pay any applicable fees or taxes under this Software License Agreement. You will be responsible for all reasonable expenses (including attorneys' fees and court costs) incurred by Microix in collecting such fees or taxes from You. All rights and licenses granted by Microix to You under this Software License Agreement will terminate. All fees incurred by You as of the date of termination will become immediately due and payable to Microix. You will not be entitled to a refund of any fees paid by You to Microix under this Software License Agreement. Upon any termination of this Software License Agreement, You must cease all use of the Software, destroy all copies then in Your possession or control and take such other actions as Microix may reasonably request to ensure that nocopies of the Software remain in Your possession or control.

## **10. JURISDICITION RIGHTS**

This Agreement gives You specific legal rights, and You may also have other rights, which vary from jurisdiction to jurisdiction. Some jurisdictions do not allow the exclusion or limitation of implied warranties or of liability for incidental or consequential damages, so some or all of those sections of the Agreement may not apply to You.

## **11. TERM**

This Agreement is effective from the date You accept it and continues in effect until terminated. You may terminate this Agreement at any time, at which point Your license hereunder will terminate. This Agreement and the license granted herein will terminate automatically and without notice if You fail to comply with any term or condition of this Agreement. You agree upon termination to return the original Software to Microix and to destroy all other Software copies in Your possession. Any provision in this Agreement which when reasonably read is intended to survive the termination of this Agreement shall survive, including without limitation, the disclaimer of warranties and limitations of liability.

## **12. ENTIRE AGREEMENT AND SEVERABILITY**

This Agreement (including the Supplemental License Terms which are incorporated by reference and made a part hereof) represents the complete and exclusive understanding between You and Microix regarding the Software, and supersedes any prior purchase order, confirmation, advertising, representation, or other communication. This Agreement may not be modified except by a written agreement signed by an authorized Microix representative. If any provision of this Agreement is found to be void, invalid, or unenforceable, it shall be severed from and shall not affect the remainder of this Agreement, which shall remain valid and enforceable. Any such severed provision shall be replaced with a similar provision, which conforms to applicable law and embodies as closely as possible the original intent of the parties.

# 13. DISPUTE RESOLUTION, WAIVER OF COLLECTIVE OR CLASS ACTION, CHOICE OF LAW, STATUTE OF LIMITATIONS AND LANGUAGE

Any cause of action or claim arising out of or relating to this Agreement or the breach thereof, including without limitation, the validity, enforceability, or scope of this Agreement, shall be settled by binding arbitration pursuant to this **section 13** and the applicable rules of either J.A.M.S/Endispute or the National Arbitration Forum in effect at the time the claim is filed. Judgment upon the award rendered by the arbitrator may be entered in any court having jurisdiction hereof. In addition, You agree that any cause of action or claim will be arbitrated individually and that You will not consolidate or seek class treatment for any claims, unless previously agreed to in writing by You and Sage. This Agreement shall be governed by the laws of (i) the State of Georgia if primary Use of the Software occurs in any jurisdiction other than Canada, or (ii) the Province of British Columbia if primary Use of the Software occurs in Canada, without regard to the conflict of laws provisions thereof or to the United Nations 1980 conventions on the International Sale of Goods. The parties have expressly requested and required that this Agreement and all other related documents be drawn up in the English language.

ANY CLAIM OR CAUSE OF ACTION, REGARDLESS OF FORM, MUST BE BROUGHT NO MORE THAN ONE (1) YEAR AFTER IT AROSE, OTHERWISE THE CLAIM OR CAUSE OF ACTION SHALL BE BARRED, EXCEPT THAT THE FOREGOING LIMITATION AND THE ARBITRATION PROVISION SHALL NOT APPLY TO THE ENFORCEMENT BY MICROIX OF ANY OF ITS INTELLECTUAL PROPERTY RIGHTS. THIS PROVISION SHALL SURVIVE TERMINATION OF THIS AGREEMENT.
